1 GENERAL

Giesen Coffee Roasters warrants the proper operation of the products purchased by you, subject to the following conditions.

2 ARTICLE 1

Subject to these conditions, Giesen Coffee Roasters will, free of charge, repair any defects that may manifest themselves in its products within the warranty periods stated for each product group in annex 1 as from the date of shipment of the product from the Giesen Coffee Roasters facility or the date on which the product was made available for collection (hereinafter: "ex works"). Any products not listed in the annex will be subject to a maximum warranty period of 12 months from the date of shipment "ex works". Used or refurbished products will be subject to a maximum period of 12 months as well. Any parts ordered through the webshop will be subject to the same period, however, always calculated from the date of the invoice.

The maximum warranty period will at all times be the number of roasting hours stated, unless the warranty period expressed in years expires before the number of roasting hours stated has been reached.

The warranty will only apply in the event of normal use of the products. In terms of use intensity of the products, this means that the products are used daily for a maximum of 4 roastings per hour, 6 hours per day, during 260 (workable) days per year. This means a maximum of 1560 roasting hours per year. If this requirement has not been met, Giesen Coffee Roasters will be authorized to reject the warranty.

3 ARTICLE 2

The warranty will only apply to any defects that have come to light to the extent that such defects are based on faults in material or workmanship. If any such defects occur, the relevant parts will be made available free of charge and no labour costs will be charged. The warranty performance entails that the product is restored to the condition it was in before the defect occurred, free of charge.

4 ARTICLE 3

Any defects must be reported promptly. The warranty claim will expire if the defect is not reported within 48 hours of discovery by email to the email address support@giesen.com or service@giesen.com.

5 ARTICLE 4

Any replaced parts will, at Giesen Coffee Roasters' discretion, become the property of Giesen Coffee Roasters, and must, at Giesen Coffee Roasters' request, be returned to Industrieweg 15, 7071 CK, Ulft, the Netherlands.

6 ARTICLE 5

The warranty claim will expire in the event of careless use, in a situation as described in article 9, paragraph 6, of the general terms and conditions, and/or if it cannot be demonstrated that, since installation, the product has been maintained by Giesen Coffee Roasters or its dealers and agents or according to the maintenance requirements and a demonstrable log, as required by the user manual.

7 ARTICLE 6

The warranty does not relate to any defects as a result of transport damage, defects arisen outside the responsibility of Giesen Coffee Roasters, or defects due to inexpert installation and/or assembly.

Expert installation and/or assembly means that the installation and connections of the gas supply, electricity, the smoke control ducts, water supply, and air ducts of the roaster and/or other products have been implemented in accordance with the pre-installation guide or the user manual.

If an installation drawing has been made, the installation and connections must be installed in accordance with the technical specifications of such installation drawing. In the event of conflict between the technical specifications in the installation drawing and the specifications in the data sheets and manuals, the technical specifications in the installation drawing will prevail.

Installation and connection will at all times be the responsibility of the customer. The connections may only be installed by (local) electrical, gas smoke control duct certified persons; otherwise, the warranty will not be valid. Whether a person satisfies this warranty condition will be at the discretion of Giesen Coffee Roasters.

8 ARTICLE 7

The warranty claim will expire if the defect is caused repairs or interventions within the warranty period by third parties other than Giesen Coffee Roasters and/or if the product has been fitted out with any non-original accessories or parts.

9 ARTICLE 8

In no event will any repair under warranty extend the warranty period or lead to commencement of a new warranty period, other than for the parts used in the repair work.
